15 NATIONAL MONUMENTS TO RECEIVE FUNDING AS PART OF NATIONAL MONUMENTS FUND 2019

Singapore, **10 September 2019 –** Keeping one of Singapore's surviving examples of English Neo-Gothic architecture – not to mention the oldest Anglican place of worship – in good condition, is no easy task. To help with the cost of its upcoming restoration and maintenance plans, the St Andrew's Cathedral will be receiving funding from the *National Monuments Fund (NMF)* as a first-time recipient.

- The *NMF* is a co-funding grant that addresses the challenging task of up-keeping historic buildings and structures. Administered by the National Heritage Board's (NHB) Preservation of Sites and Monuments (PSM) division, the fund aims to assist eligible monument owners in the restoration and maintenance of our built heritage. Please refer to **Annex A** for the full list of National Monuments eligible for the application of the *NMF*.
- Since the introduction of the *NMF* in 2008, the fund has grown¹ and adapted to better serve the evolving needs of our National Monuments and their owners. For example, in 2015, a new funding category *Maintenance Fund* was introduced in view of the frequent and important maintenance works National Monuments require. Complementing the original *Restoration Fund*, it serves to ensure that monument owners conduct regular maintenance work to restrain building deterioration, so as to prevent incurring costlier restoration works in the future. Safeguarding Singapore's Built Heritage with the Community

Ms Jean Wee, Director of the PSM division, NHB, said: "Our National Monuments are important symbols of our past, protected today by the diverse communities they continue to serve. We hope this continues for future generations, through means such as the *National Monuments Fund* which is a co-funding support towards that end. Over the years, the fund has enabled us to deepen our partnership with stakeholders. Beyond being a funding stream, it is also about the sharing of knowledge and principles of good restoration. We are also very encouraged by strong positive feedback. Fourteen of the 15 grant recipients this year are repeat applicants. This augurs well as an indication that earlier restoration has spurred them to continue and widen their preservation efforts on site."

¹ The *NMF* started with a first tranche of S\$5 million in 2008, and was subsequently given a second tranche of S\$11.77 million in 2015.

² The *Maintenance Fund* covers regular work to identify building issues early and pre-empt necessary restorative works, while the *Restoration Fund* covers rectification works that restore the spirit of the buildings' historical fabric.



This year, a total of S\$2.61 million will be disbursed to 15 National Monuments. Of this, S\$2.5 million will help co-fund restoration works and S\$115,000 will co-fund maintenance works of the National Monuments. As both funds are designed to be complementary, some National Monuments are recipients of both funds. Please refer to **Annex C** for the list of 2019's *NMF* recipients.

- One example is the St Andrew's Cathedral, which is a first-time *NMF* recipient. Completed in 1861 and gazetted as a National Monument in 1973, the Cathedral sits on the site which was chosen for a church by Sir Stamford Raffles in 1823. The original St Andrew's Cathedral, which was completed in 1837, no longer stands as it was struck by lightning twice in 1845 and 1849, and had to be reconstructed.
- Through the years, the St Andrew's Cathedral has remained an important place of worship for the Anglican Communion in Singapore, and also a landmark in the heart of the Civic District. It was last restored in 1991, and this year, the Cathedral is a first-time recipient of both the *Restoration Fund* and *Maintenance Fund*. Its scope of work includes the removal of plaster and repainting of the entire Cathedral; restoration to pews, stalls, doors and windows; repair or refurbishment of timber flooring in bell tower; termite control; removal of vegetation on or near the Cathedral; and spot repair of artefacts or features.
- 8 Mr Lee Chi Kuan, Chair, Restoration Works Committee for the St Andrew's Cathedral, said: "The Cathedral is a part of the Civic District and has a significant place in terms of heritage and a tourist destination. We have been considering and planning the restoration of the Cathedral for some time now, and the grant from *NMF* will help us defray a substantial part of this cost. Our building needs to be kept in a good state of repair as a witness to our stewardship and responsibility we are heirs to the past, stewards of the present and trustees for the future."
- 9 Other recipients of the *Restoration Fund* include the Thian Hock Keng Temple and Church Of Nativity Of The Blessed Virgin Mary, both of which are third-time recipients of the *NMF*; and fourth-time recipients the Chesed-El Synagogue and Maghain Aboth Synagogue.
- 10 Mr Hertzel Lelah, Member of the Board of Trustees of the Chesed-El Synagogue, said: "The Trustees of the Chesed-El Synagogue are extremely grateful for the support received from PSM over the years; we are a small charity with limited access to contributions from our



congregation and from other kind donors. For instance, during our major restoration in 2016, we not only were supported by PSM in the form of the *NMF*, but again the advice and assistance received – to prevent our front canopies from collapsing, to fixing our leaking roofs and in replacing the worn out floor tiles – went a great way to restoring the Synagogue to its former glory."

11 Chesed-El Synagogue will be utilising the *Restoration Fund* received for 2019 to address the unique challenge of the Synagogue being built in front of a retaining wall. The grant will be supporting the costs for micro-piling and reinforcing the wall. Mr Lelah added: "The dedication and effort that the PSM staff have put into preserving and maintaining the many National Monuments in Singapore are greatly appreciated not only by the management of these sites, but also by the millions of visitors who come to view these National Monuments each year."

The Preservation of Sites and Monuments (PSM) division, under the National Heritage Board (NHB) and with advice from the PSM Advisory Board, guides the preservation of buildings, monuments and sites, which commemorates Singapore's heritage as defined under the Preservation of Monuments Act. The PSM division also leads NHB's joint efforts with National Parks Board to list the Singapore Botanic Gardens as Singapore's first UNESCO world heritage site. It also oversees the 100 heritage sites that have been marked by NHB.

The PSM division's administration of the preservation gazette is complemented by its outreach objectives to promote a renewed appreciation and understanding of national monuments and their history, and to encourage people to relate to them as sites of memory that convey a sense of place, identity and belonging. Annex B

About the NMF

In 2008, the *National Monuments Fund (NMF)* was introduced with a first tranche of S\$5 million, dedicated to monument restoration works. In 2015, in recognition of the growing needs of our National Monuments, and to better support the monument owners in addressing these needs, the *NMF* was given a second tranche of funding of S\$11.77 million.

In addition to its increased funding pool, the enhanced *NMF* in 2015 went beyond restoration to include a new category of funding for maintenance. This *Maintenance Fund* was allocated S\$2 million from the second tranche (of S\$11.77 million), and aims to ensure that stakeholders conduct regular maintenance work to restrain building deterioration, thereby preventing unaddressed works from snowballing into significant restoration costs. Monument owners will be able to receive funding from PSM for regular maintenance work based on their identified needs.

To encourage responsible ownership of the National Monuments, the *NMF* is disbursed through a co-funding scheme. Application is open to National Monuments that are owned and managed by non-profit or religious organisations. To apply, monument owners will need to be able to financially co-support the restoration and or maintenance works, and the disbursement quantum is individually assessed based on the severity and urgency of the scope of work required for rectification.

The outstanding costs of works not covered by *NMF*, including those for upgrading and enhancement works unrelated to but done in conjunction with the restoration or maintenance process, are usually covered by donations raised by the monument owners.
